Attendees do not have to submit a continuing education request form or obtain a signature from a NJAPZA representative for League conference sessions. Retain your certificates with your continuing education records and submit copies with your renewal application packet. **Do not** submit copies of these certificates to CGS immediately after the League concludes. They will only be accepted with your renewal application. Please be sure to print your certificates from the League's website prior to their May 2018 deadline.
